

CONTRACT OF CONSENT

For a Play Performance, Play Demonstration, Service Top Session & Play Scene

I, (your name) _____ aka (scene name) _____, being of sound mind agree to engage in BDSM activities, listed below in this contract, with _____ aka _____ (The Top, Dominant, Dom, Domme, Master, Mistress), hereafter to be referred to as “The Top” in this contract. I understand that I am choosing to sign this contract of my own free will without coercion or duress. I agree that I am signing this contract while sober and that I am not currently under the influence of any alcohol substance or any mind-altering drugs. I agree that I am at least 18 years of age or older at the time of signing this contract. I am aware that BDSM activities are dangerous both physically and mentally, in that we are play-acting fantasies of mock abuse, fictitious non-consent and simulated corporal punishment that includes actual physical strikes to my person (body). I understand that I may stop any BDSM activity at any time and revoke my given consent.

I understand that at the time of signing this contract, The Top is not aware of any allegations of non-consent or misconduct against him/her. I understand that he/she will make me aware of any such claims prior to engaging in any BDSM activities. I agree to disclose to The Top any past traumas of abuse, (without naming persons involved), that might adversely affect any BDSM activities prior to engaging in said BDSM activities with The Top.

I agree that I will disclose to The Top any medical conditions, psychiatric conditions or allergies that I may have prior to engaging in BDSM activities.

I agree that directly prior and during any BDSM activities with The Top that I will not become heavily intoxicated or under the influence of any drugs that could obstruct my decision-making process. If I, as an adult over the age of 21 years of age, choose to drink or take drugs prior to and/or during any BDSM activity with The Top, that I will notify him/her immediately should I feel that I am no longer sober enough to consent or to revoke consent. I am aware that The Top will be checking on my mental state and overall mental health during any BDSM activity and that he/she will be actively looking for signs of me wishing to stop any BDSM activity. However, I will not hold The Top responsible should I become too intoxicated to revoke consent, unless I have made it known to him/her that I am too intoxicated and my judgment is impaired. Should I black out, pass out, become unconscious or become overtly incoherent for any reason, I am aware that ALL activities will cease immediately. I understand that if I show signs of extreme intoxication, ALL activities will cease and that a cooling off period of no less than 24 hours will ensue.

I understand that all BDSM activities will begin when both parties say aloud that we are in “play mode” and then either party can end BDSM activities at any time for any reason. I understand that aftercare comes after any BDSM activities (scene or session) and is not considered a part of the BDSM activity (scene or session). I understand that I can stop any BDSM activity at any time and that I may also stop aftercare at any time. I agree that I have been made completely aware that I can stop any BDSM activity with The Top by

saying aloud a predetermined safe word (safeword) and/or saying the word “stop” and/or the word “no” and/or signaling a predetermined safe sign (safesign).

DISCLOSURE TO THIRD PARTIES

I am aware and agree that if for any reason The Top feels that there is a medical emergency, he/she will call for help and/or seek professional medical services, even if it means exposing to third parties the BDSM activity and people involved.

I understand that this contract may not be shared to third parties, unless there are any claims of misconduct or non-consent issues, arising as a result from any BDSM activities.

ACTIVITIES

I consent to engage in the following BDSM activities below. I agree that I will draw a line through and initial by any activity that I do not wish to engage in, indicating an activity that is not to be included in this contract of consent.

BDSM activities are as follows:

- Spanking on my back, breast and ass.
- Flogging on my back, breast and ass.
- Whipping on my back, breast and ass.
- Birching on my back and ass.
- Caning on my ass, thighs or legs.
- Bondage.
- Mouth gags.
- Blindfolds
- Humiliation such as being told what to do in public.
- Humiliation such as public nudity of my breast, where it is legal.
- Humiliation such as public nudity of my ass, where it is legal.
- Humiliation such as public nudity of my sexual organs (vagina or penis), where it is legal.

I agree that if I have any limits on the above BDSM activities that I will state them clearly to The Top, prior to engaging in any BDSM activities.

HUMILIATION PLAY

I understand that *ALL* BDSM activities could be viewed as a form of humiliation, due to any sort of power exchange that may take place between The Top and myself. I understand that it is my responsibility to clearly define what is considered humiliation to me. If I agree to any sort of actual “humiliation play”, I understand that I discern what is considered humiliation and will be forthcoming and concise about my definition of humiliation prior to play. I agree that I will draw a line through and initial by any activity that I do not wish to engage in, indicating an activity that is not to be included in this contract of consent.

Activities that might be considered humiliation may include:

- Face slapping (very light open hand).
- Hair pulling.
- Name Calling.
- Belittling with emphasis on your current Age.
- Belittling with emphasis on Body Type.
- Belittling with emphasis on Gender.
- Belittling with emphasis on your intellect or lack thereof.
- Mock worshiping of me or a body part.
- Leading by way of a leash or collar.
- Being ordered to do any sort of task or to be given direction in such a manner as though The Top is in charge of me during the play session.

I understand that humiliation is highly subjective and I will stop the session if I feel that anything is hurting my self-esteem. I agree to list any limits to what I consider humiliation in the hard/soft limits section of this contract.

GEAR / IMPLEMENTS

I consent to The Top using the following implements on me. I agree that I will draw a line through, and initial by any implement that I do not wish to be used on me, indicating an implement that is not to be included in this contract of consent.

Gear inventory may include:

Bondage:

- Collars (leather, chain or PVC).
- Handcuffs.
- Rope (hemp, cotton, jute, manila, nylon, polyester).
- Cable ties or Plasticuffs.
- Leather or rubber wrist cuffs with locks.
- Leather or rubber ankle cuffs with locks.
- Suspension cuffs.
- Leather bondage belts.
- Ball gags.
- Bit gags.
- Harness gags.
- Muzzle gags.
- Ring gags.
- Spider gags.
- Utility gags.
- Blindfolds.
- Spreader bars.
- Bondage straps.
- Bondage tape.
- Nipple clamps (tweezer or clover).

- Breast clamps.
- Clothespins.
- Pallet packing stretch wrap or kitchen cling wrap.
- Swivel clips attached to chains.

I agree to ask any questions I may have about the above implements, the condition of the gear, or the use thereof, prior to play and I agree to not engage in play with The Top until all my questions have been answered to my complete satisfaction. I agree that if I have any limits on the above implements or use thereof, that I will state them clearly to The Top prior to engaging in any BDSM activities.

I agree that if I have any limits on any of the above activities that I will state them clearly to The Top prior to engaging in any BDSM activities.

MARKS

I understand that some BDSM activities may cause marks such as bruises, wheals or superficial wounds on my skin. I understand that everyone's skin reacts differently as to the severity of soreness or bruising due to heredity and diet prior to play. I also understand that everyone's skin heals at different rates. I understand that some implements or impact play can cause minor bleeding to occur. I agree to notify The Top of any place that is off limits for any sort of impact play or any parts of my body that I need to avoid marks. I agree to notify The Top of any medical condition that can affect blood clotting or healing of bruises.

Below is a list of any limits to areas of my body that I wish to avoid marks, as well as any medical conditions that limit impact play.

I understand that if any marks or bleeding seem too severe, The Top will stop the play to tend to the wounds. I understand I maintain the ability to stop a play session at any time to look at a mark or wound that I am concerned about.

ASSISTANTS

I understand that _____ (assistant) aka _____ may be assisting The Top during BDSM activities. His/her role will be to help watch for my mental state and health, however, I will not hold him/her responsible in any way for my mental state and health. I am aware that the assistant assumes no responsibility for my mental state and overall health during any BDSM activities.

HARD and/or SOFT LIMITS

Any of my hard and/or soft limits, defined as activities not to be engaged in for any reason at any time, are listed below.

AFTERCARE

Aftercare is not part of the play session. Only the very basic aftercare will be provided *unless you request otherwise*. Basic aftercare includes making sure that you are safe and in a safe place to unwind for up to fifteen minutes after the play session. I will check on your mental state, your mental wellbeing, your comfort, and I will check any physical marks you might have received from the play session. Any additional aftercare that you require must either be written here before play begins, or *verbally requested during the fifteen minutes of basic aftercare*. I will not assume that I can touch your body, including a hug or a cuddle, without you asking for it. When playing in an open dungeon, often there are other patrons waiting for the space. During the first ten minutes of basic aftercare,

I may need to gather my gear and equipment to make room for other patrons. ***If you require any additional aftercare beyond what is described as basic aftercare in this contract, you must request it.***

List Aftercare request here:

*** PLEASE NOTE: This is a signed agreement between two to three parties for the purpose of showing intent and to serve as an aid in BDSM safety. Signing this contract does not guarantee your safety nor does it free anyone from abiding by federal or state laws. This is not meant to be a legally binding contract nor is it meant to serve as professional legal advice. In some states, some BDSM activities may be considered illegal even with the presence of consent. By signing this contract, you risk the possibility of showing proof that you are ignoring the legalities in order to also show proof of an attempt to gain full consent. If you are concerned of showing proof of your involvement in BDSM, you should consider not writing your name or your signature on the contract and instead use it as a worksheet to help aid in successful negotiations before BDSM play session.
